For over 40 years, James C. “Jim” Hardin III has devoted his legal career to complex estate planning matters, including business succession, asset protection, probate, trust administration, charitable giving and service as an expert witness in trust and estate litigation matters.

Jim is a board-certified specialist in estate planning and probate law in both North and South Carolina. He has been an elected fellow of the American College of Trust and Estate Counsel (ACTEC) since 1986, serving as its South Carolina State chair from 2001 to 2006. He has also been selected as one of the Best Lawyers in America® in Trusts and Estates since 1987 receiving its 2014 Charlotte Trust and Estates “Lawyer of the Year” distinction, as well as South Carolina and North Carolina Super Lawyers® on numerous occasions, including having been selected as one of the top 100 North Carolina Super Lawyers® in all fields of law in 2006 and listed in Business North Carolina’s Legal Elite. He has chaired or served as a member of South and North Carolina Bar committees which have studied and assisted in enacting the South Carolina Probate Code in 1986, the South and North Carolina Trust Codes in 2005, the revised Uniform Principal and Income Act in both Carolinas and the South Carolina Prudent Investor Act.
